A. Independent Living Facility Project Update 8:45 am A Carrillo

i. Letters of Support

A Fleck updated the group as to the intent and purpose of the letter of support templates that were distributed with the agenda for this meeting. The intent is to elevate the status of the ILFP so that it makes it to the RFP process for Innovations Funding. He asked the group to help disseminate the letter throughout the community to continue gathering support.

iii. ILF Resource Fair
